WHERE/WHEN SHOULD I SUBMIT MY VICTIM Victim Impact ...

We recommend that your Victim Impact Statement focus on the impact the crime has had on you, your family and/or your loved ones It shouldn't be too long, yet long enough to communicate how the crime has affected you Be sure to include the following information when writing your Statement:

- Your name and /or Victim's Name
- Offender

Part of your role is helping victims understand what will remain confidential and what will not Most jurisdictions have laws to protect victim's privacy; these laws often focus on: Requiring testimony in open court that would reveal personal information Limiting a victim's identifying information in records

Under Minnesota law, a crime victim is defined as a person who incurs loss or harm as a result of a crime A victim includes the family member, guardian, or custodian of a minor, incompetent, incapacitated, or deceased person As a victim of crime, Minnesota provides you with important rights as your case moves through the criminal justice system
